Shellfish Permit holders shall estimate the previous year's shellfish catch and file it with the Shellfish Constable (If you did not do any shellfishing, write "0" on the catch report and return) **A new Shellfish Permit will not be issued until this form have been completed** and submitted by the Permit Holder. The information will be held confidential. We use these figures to track which shellfish beds have been most heavily harvested and, therefore, need replenishing with seed.
