Off season rate (Oct. 15 – April 30) ½ price**

All applications will henceforth be made using the [mail-in form](#) only. The form can be printed out or picked up at Chatham Dept. of Coastal Resources, the Chatham Police Dept or Town Hall (Town Clerk's Office). Completed forms must be mailed to the Coastal Resources Department, 549 Main St. Chatham MA 02633. NO DROP-OFF APPLICATIONS ACCEPTED.

Note: Camp Owner stickers will no longer be issued as there are no camps accessible over land by ORV. ORV stickers, however, will be issued at no charge to North Beach Island camp owners and to 1st Village property owners who lost their camps since April, 2007. (Two stickers per property. A copy of the deed is required.)

2011 North Beach Off Road Vehicle (ORV) Sticker Mail-In Form Instructions

To be eligible for a Chatham Resident North Beach ORV sticker, the applicant must either be a legal resident of the Town of Chatham or an owner of property in the Town of Chatham.

1. Print out the [mail-in form](#) or pick one or more up at either:

2. Submit an application for each ORV for which you want a sticker. Please fill out the form completely and legibly.

Be sure to watch the [Nauset Beach Video](#) and to read the [Nauset Beach Rules and Regulations](#). Your signature on the lower portion of the mail-in form certifies your completion of the video and understanding of the Rules and Regulations. *You are responsible for having all the necessary equipment in your vehicle and adhering to the Rules and Regulations.*

3. Include a photocopy of the current registration for your ORV. *Stickers will not be issued without it.*

4. If your ORV is leased, include a photocopy of your lease agreement showing your name and the vehicle's registration number.

5. **IMPORTANT:** Include a stamped, self-addressed business size (#10) envelope with each application.

6. The ORV sticker fee is \$40.00. Make checks payable to Town of Chatham.

7. Applicants must be listed in the assessors' files (property owners) or the census (residents). You can check on this on-line on the [Assessors' Database](#) or at the Town Clerks on the [Town Census](#). If you are not listed, you must include documents proving residence or property ownership. Copies of a deed, or a driver's license or electric bill with your name and Chatham address will suffice.

8. If you are a business property owner with an ORV leased to that business, include a copy of the lease as well as a letter stating your connection to the company on the company's letterhead.
