RENEWALS FOR NON-RESIDENT SHELLFISH LICENSES - \$80.00
CANNOT BE OBTAINED IN PERSON AT PERMIT OFFICE UNTIL AFTER MAY 15TH

We have you in our records as having received a Non-Resident Shellfish Permit for the last two consecutive seasons. If you have a turquoise license for 2008-2009, it will expire on May 31, 2009.

To renew your shellfish permit by mail, please do the following:

1. If you are mailing this form back before May 31st, retain your 2008-2009 permit (so that you will have a permit in your possession if you go clamming) and complete the catch report below. If you are mailing after May 31st, fill out **catch report** below or the one on the back of your expired permit and mail back to us.
2. Enclose your check in the amount of **\$80** for each permit you are requesting, payable to **Town of Chatham**, and mail to Permit Office, 283 George Ryder Road, Chatham, MA 02633
3. **A SELF-ADDRESSED, STAMPED ENVELOPE IS REQUIRED.** (If omitted, your permits will be held to be picked up by you after May 15th.)
4. Your new permit **will not be mailed back to you until May 15th**.

Shellfish Permit holders shall estimate the previous year's shellfish catch and file it with the Shellfish Constable c/o Permit Department. (If you did not do any clamming, write **0** on the catch report and return.) **A new Shellfish Permit will not be issued until this form has been completed** by the Permit Holder. The information will be held confidential. We use these figures to track which shellfish beds have been most heavily harvested and therefore need replenishing with seed. If you are not going to renew your license, please fill out the catch report on the bottom of this page or on your license and return to us.
