Sewer Construction & Road Paving Update

Chatham – C.C. Construction, Inc. will continue work for the Phase 1D-2A: Route 137 – Morton Road Sewer Extension Project (1D-2A) and the Queen Anne Pumping Station (QAPS) Upgrade as outlined below. N&M Excavating LLC will continue work for the Crowell Road Phase 2 & Chatham Fish Pier Infrastructure Project (Crowell Road Phase 2 and CFP) as outlined below.

Work for the week of December 19th – December 23rd:

1D-2A:

- Continued sewer work expected on Meetinghouse Road, work is progressing north from the Rt. 28 intersection. *Detour utilizing Morton Road in place.*
- Tentative site work at Pump Station #3 (Meetinghouse Road).

Crowell Road Phase 2 and CFP:

- Paving expected on Crowell Road between Stony Hill Road and Tip Cart Drive on Monday 12/19. *Detour will be in place: Portion of Crowell Road will be closed between Stony Hill Road and Tip Cart Drive, and Lake Street will be closed. Traffic will be detoured via Tip Cart Drive to Barcliff Avenue to Old Harbor Road to Orleans Road to Stony Hill Road.*
- No other work is expected 12/20 through 12/23.

QAPS:

- No work expected.

Two Week Look Ahead (12/26 – 12/30): **No Work on Monday 12/26 (Christmas Holiday – Observed)

1D-2A:

- No work is expected.

Crowell Road Phase 2 and CFP:

- No work expected.

QAPS:

- No work expected.

Three Week Look Ahead (1/2 – 1/6): **No Work on Monday 1/2 (New Year's Day – Observed)**

1D-2A:

- Continued sewer work expected on Meetinghouse Road, work is progressing north from the Rt. 28 intersection. *Detour utilizing Morton Road in place.*
- Tentative site work at Pump Station #3 (Meetinghouse Road).

Crowell Road Phase 2 and CFP:

- Continued drainage work expected on Crowell Road between Stony Hill Road and Tip Cart Drive. *Detour will be in place: Portion of Crowell Road will be closed between Stony Hill Road and Tip Cart Drive, and Lake Street will be closed. Traffic will be detoured via Tip Cart Drive to Barcliff Avenue to Old Harbor Road to Orleans Road to Stony Hill Road.*

QAPS:

- Tentative site work at pump station site (40 Queen Anne Road; SE corner of Queen Anne Road and Oyster Pond Furlong).

Please note that this is a projected schedule and will be adjusted accordingly based on the Contractor's actual progress and the weather.

Roads will be passable at the end of each day. Police Details and Contractors will work with residents to ensure their needs for access are addressed.

Police Details and signage will be in-place to assist motorists in reaching their destination.

Normal work hours are 7:00 AM to 4:00 PM Monday to Friday, weather permitting, unless otherwise noted.
