

Town of Chatham 2017-2018 BEACH and TRANSFER STATION STICKERS

STICKERS MAY NOT BE OBTAINED AT THE STICKER OFFICE (508-945-5180) BEFORE MAY 15TH

(2016-2017 Beach and Transfer Station Stickers expire June 30, 2017)

NOTE: Stickers will not be mailed back to you until after MID-MAY

- Complete and sign application below, mark **which** sticker you want for **each** vehicle. *We must have your Chatham street address (in addition to a P.O. Box if you have one) so that Assessors records can be verified. If your name is different from the one listed on the property title, and you have not previously registered your claim with the Permit Office, provide documentation establishing you as an owner or your relationship to the owner (i.e. spouse with different name). Trust documents must have been recorded at the Barnstable Registry of Deeds.*
- INCLUDE A COPY OF CURRENT, NOT EXPIRED, VEHICLE REGISTRATION FOR EACH VEHICLE.**
 - Registration(s) must reflect a Chatham address for those individuals claiming full-time legal residency.
 - If vehicle is not registered in Chatham or is registered to a post office box:** in addition to registration, you **MUST** provide a copy of a tax bill or deed showing your name linked to your Chatham address.
 - If vehicle is LEASED and registration does not identify you by name as lessee:** in addition to registration, you **MUST** send a copy of lease agreement, monthly bill for lease, or proof of insurance, each of which **MUST** include the Vehicle Identification Number (VIN#) matching that of the registration and with your name linked to the vehicle, and proof of residency as in 2a.
 - If vehicle registration is in COMPANY NAME:** you **MUST** send proof of employment linking you to the business (pay stub, business card, etc.) or proof of insurance naming you as driver in addition to the registration and proof of residency as in 2a.
(Note: The Sticker Office does not keep copies of registrations, leases, etc. on file. They will be mailed back along with your sticker(s).)
- SELF-ADDRESSED, STAMPED ENVELOPE IS REQUIRED. (IF OMITTED, STICKER(S) WILL NOT BE MAILED,** but will be held at the Sticker Office for you to pick up after May 15th.)
- Enclose a (do not combine with tax payment) check **payable to the "Town of Chatham"** in the proper amount (use the form below to figure your total) (you may combine with shellfish permit) and mail to: Chatham Sticker Office, 261 George Ryder Road, Chatham, MA 02633.
- Stickers must be placed **INSIDE** the **WINDSHIELD** on the **DRIVER'S SIDE** in the lower left corner.
